

## License Agreement for Software

**Important - read carefully.** This License Agreement is a legal agreement between **you** (either as a registered individual licensee or as the representative on behalf of a single entity) and Peter Soxberger ("**Manufacturer**") for all its software products, which may include associated media, printed materials, and electronic documentation ("**Software**"). By installing, copying, or otherwise using the Software, you agree to be bound by the terms of this agreement. If you do not agree to the terms of this agreement, then **do not** install or use the Software.

The Software is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties.

**Limits of Use.** The Software may be used only by you. You may install and use one copy of the Software on a single computer. You may also store or install a copy of the Software on a storage device for backup purposes. Any given license to use the Software may not be shared or used concurrently or otherwise on different computers or by different developers in a given organization.

**Redistribution.** You are authorised to integrate the software into your products and to sell the software together with your products. You agree to take technical measures (encryption of the Prototype-/Call up Syntax) to avoid the use of the software by a third party. You are not allowed to sell a stand-alone version of the software. You are not allowed to use the demo version of the software for any commercial projects. The popup window that appears on application start may not be suppressed.

**Limitations on Reverse Engineering.** You may not reverse engineer, decompile, or disassemble the Software, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation of components. The Software is licensed as a single. Its component parts may not be separated.

**Rental.** You may not rent, lease, or lend the Software to any party.

**Support Services.** The Manufacturer provides you with email support services related to the Software ("Support Services") under the following conditions: The Support Services can only be used with a valid Support ticket or until one month after you bought a full Version of the Software. Any supplemental software code provided to you as part of the Support Services shall be considered part of the Software and subject to the terms and conditions of this agreement. With respect to technical information you provide to the Manufacturer as part of the Support Services, the Manufacturer may use such information for its business purpose, including for updates and development. The Manufacturer will use its best efforts to not utilize such technical information in a form that personally identifies you.

**Termination.** Without prejudice to any of the Manufacturer's other rights, the Manufacturer may terminate this Agreement if you fail to comply with the terms and conditions of this Agreement. In such event, you must destroy all copies of the Software and all of its component parts. To this end you grant to the Manufacturer the right to, with or without notice, monitor your Internet accessible activities for the purpose of verifying the Software performance and/or your compliance with the terms hereof, including, but not limited to the remote monitoring and verification of your implementation, use and duplication of the Software. The Manufacturer reserves the right to disable your copies of the Software and void your license, your passwords and update rights if you violate the terms and conditions of this Agreement

**Upgrades.** If the Software is labeled or otherwise identified by the Manufacturer as an "upgrade", you must be properly licensed to use a product identified by the Manufacturer as being eligible for the upgrade in order to use the Software. Software labeled or otherwise identified by the Manufacturer as an upgrade replaces and/or supplements the product that formed the basis for your eligibility for such upgrade. You may use the resulting upgraded only in accordance with the terms of this Agreement. If the Software is an upgrade of a component of a package of software programs that you licensed as a single, the Software may be used and transferred only as part of that single package and may not be separated for use on more than one computer.

**Dual-media Software.** You may receive the Software in more than one medium. Regardless of the type or size of the medium you receive, you may use only that one medium that is appropriate for your single computer. You may not use or install the other medium on another computer. You may not loan, rent, lease, or otherwise transfer the other medium to another user, except as part of the permanent transfer (as provided above) of the Software.

**Limited warranty.** As Peter Soxberger sells the software as a private person and not as a company, no warranty is granted (according to EU warranty laws).

**Customer remedies.** In case the software or parts of it do not meet the described functions Peter Soxberger will either fix the bug with an update or take the software including all backups, documentations and prints back against refunding the price. This is only when it is clear that there is a bug in the software and not a miss usage. Any claim is limited to the price of the software.

**Limitation of liability.** To the maximum extent permitted by applicable law, in no event shall the Manufacturer or its suppliers be liable for any special, incidental, indirect, or consequential damages whatsoever (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or any other pecuniary loss) arising out of the use of or inability to use the software product or the provision of or failure to provide support services, even if the Manufacturer has been advised of the possibility of such damages. In any case, the Manufacturer's entire liability under any provision of this Agreement shall be limited to the amount actually paid by you for the software; provided, however, if you have entered into a support services agreement, the Manufacturer's entire liability regarding support services shall be governed by the terms of that agreement.

**Applicable law, competent court.** Any dispute arising from this Agreement will be settled under Austrian law. The court of St. Poelten, Lower Austria, shall be competent.
